***Your privacy is critically important to us. We at the Central Coast Veteran's Cemetery Foundation have a few fundamental principles:***

- We don't ask you for personal information unless we truly need it.
- We don't share your personal information with anyone except to comply with the law or protect our rights.
- We don't store personal information on our servers unless required for the on-going operation of one of our services.

The Central Coast Veteran's Cemetery Foundation ("CCVCF") is responsible and operates this site and it is our policy to respect your privacy regarding any information we may collect while operating our website.

### **Website Visitors**

Like most website operators, CCVCF collects non-identifying personal information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. CCVCF's purpose in collecting non-personally identifying information is to better understand how CCVCF visitors use its website. From time to time, CCVCF may release non-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

CCVCF also collects personally identifiable information like Internet Protocol (IP) addresses for logged for users leaving comments or questions. CCVCF only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally identifying information as described below.

### **Gathering of Personally Identifying Information**

Certain visitors to CCVCF website choose to interact with CCVCF in ways that require CCVCF to gather personally identifying information. The amount and type of information that CCVCF gathers depends on the nature of the interaction. Those who engage in transactions with CCVCF are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, CCVCF collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with CCVCF. CCVCF does not disclose personal information other than as described below. And visitors can always refuse to supply personal information, with the caveat that it may prevent them from engaging in certain website-related activities.

## **Aggregated Statistics**

CCVCF may collect statistics about the behavior of visitors to its website. For instance, CCVCF may monitor the most popular posts on CCVCF.com and may display this information publicly or provide it to others. However, CCVCF does not disclose personal information other than as described below.

## **Protection of Certain Personally Identifying Information**

CCVCF discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on CCVCF behalf or to provide services available at CCVCF website, and (ii) that have agreed not to disclose it to others. CCVCF will not rent or sell potentially personal information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, CCVCF discloses potentially personally-identifying information only in response to a subpoena, court order or other governmental request, or when CCVCF believes in good faith that disclosure is reasonably necessary to protect the property or rights of CCVCF, third parties or the public at large. CCVCF takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally identifying and personal information.

## **Cookies**

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. CCVCF may use cookies to help CCVCF identify and track visitors, their usage of CCVCF website, and their website access preferences. CCVCF visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using CCVCF website, with the drawback that certain features of CCVCF website may not function properly without the aid of cookies.

## **Privacy Policy Changes**

Although most changes are likely to be minor, CCVCF may change its Privacy Policy from time to time, and in CCVCF sole discretion. CCVCF encourages visitors to frequently check this page for any changes to its Privacy Policy.
